RAYUAN MEMPERCEPATKAN BAYARAN BALIK CUKAI GST KEPADA PEMOHON

May I, as the President of the Federation of Livestock Farmers' Associations of Malaysia, refer to the above and wish to express our concerns regarding the refunds of GST collected as input tax in excess of the output tax to those who are eligible. Our members have expressed their dissatisfaction over the delays in receiving the refunds due to them.

We were informed earlier that refunds would be made within 14 days and 28 days for online and manual submissions respectively. They have subsequently received letters from your Department that the submissions are subjected to auditing before refunds can be made. More than a month have passed since the time line for refunds to be made and our members are having serious cash flow problems in trying to keep their operations going. Our members are engaged in the production of chickens and eggs which have become staple foods for all segments of consumers of this country. The disruption in cash flow is going to affect their ability to keep in production as their financial resources are depleted. This can have a significant impact on the wellbeing of the citizens of this country.

We therefore appeal to Yang Berbahagia Dato' to look into this issue and expedite the refunds to enable us to continue serving the needs of the country. We understand the needs for audits and scrutiny of the submissions but we request that the refund is made within the stipulated time and adjustments made against future refunds if there is an amount variation post auditing as long as the farmers remain a going concern.

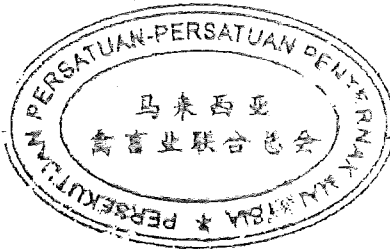
